## Friends of Seniors Endowment

### What is this endowment?

A charitable fund that support a Cumberland County Council on Older Adults every year - forever. The Cumberland County Council on Older Adults exists to help older adults living in Cumberland County maintain their independence at home with dignity by providing a variety of home and community-based supportive services.

### What is Cumberland Community Foundation (CCF)?

CCF is a charitable foundation created by and for the people in Cumberland County, NC. CCF manages over 720 different donor funds according to the charitable purpose designed by the donor. Since its inception in 1980, CCF has distributed over \$111 million in grants and scholarships to the Cumberland County region and beyond. Donors design their charitable legacy, and CCF does all the fund administration.

### How to give:

- **Give Online:** Donate online at [www.cumberlandcf.org](http://www.cumberlandcf.org). Click on the “Donate Now” button in the upper right-hand corner of the screen. Once on the donation portal, type “*Friends of Seniors Endowment*” into the search bar. Select the *Friends of Seniors Endowment* and follow the on-screen instructions to make your gift online.
- **Mail a Check:** Cumberland Community Foundation, PO Box 2345, Fayetteville, NC 28302. *Please make your check payable to Cumberland Community Foundation with “Friends of Seniors Endowment” noted in the check’s memo line.*
- **Make a Distribution from a Donor Advised Fund:** Recommend *Cumberland Community Foundation, Inc. (Tax ID: 58-1406831)* to receive a grant as an addition to the “*Friends of Seniors Endowment*”
- **Qualified Charitable Distribution from an IRA:** Donors who are 70.5 or older may make a gift directly from their IRA up to \$100,000 to *Cumberland Community Foundation, Inc. (Tax ID: 58-1406831)* for the *Friends of Seniors Endowment*. Call (910)483-4449 for instructions.
- **Donate Stock:** For convenient giving of stock and other securities, Cumberland Community Foundation has accounts at many major brokerage houses. Call (910)483-4449 for instructions.
- **Make a Beneficiary Designation:** Designate *Cumberland Community Foundation, Inc. (Tax ID: 58-1406831)* as the beneficiary of your 401k, IRA, bank and investment accounts, trust, or insurance as an addition to the *Friends of Seniors Endowment*.
- **Leave a Gift in Your Will:** Create a charitable legacy by adding a few sentences to your will. Make your gift to “*Cumberland Community Foundation, Inc., a North Carolina nonprofit corporation, as an addition to the Friends of Seniors Endowment.*”

### Make your gift in honor or in memory of a loved one:

You can make any gift to the *Friends of Seniors Endowment* in honor or in memory of a loved one. Simply indicate who the gift is in memory/honor of, and where you would like the memorial/honor card sent, and CCF will notify the individual and/or family by mailing a card.
